Admissions Criteria Changes for Bishop Walsh Catholic School for September 2021 -2022

The Board of Directors of the St John Paul II Multi Academy have made no changes in the admissions criteria for 2021- 2022 for the following schools who are:

Holy Cross Catholic Primary School
St Nicholas Catholic Primary School
Sacred Heart Catholic Primary School
St Joseph Catholic Primary School
SS Mary & John Catholic Primary School
SS Peter & Paul Catholic Primary School

In conjunction with the Board of Directors and the Local Governing Body of Bishop Walsh Catholic School has made some changes to the admissions criteria for Bishop Walsh Catholic Secondary School these are relatively minor changes but we would like to consult with parents and other stakeholders as we did last year. The number of criteria has been reduced from 12 to 10.
